





Awards up to \$175k per piece of equipment



- lift capacity > 8,000 lbs
- e.g., reach stackers, side loaders, and top loaders
- must have Tier 4 or earlier ICE engine
- can be anywhere (i.e., seaport /airport not required)
- infrastructure is eligible for funding



Awards up to \$175k per piece of equipment



- e.g., rubber-tired gantry cranes, straddle carriers, shuttle carriers, terminal tractors, yard hostlers, yard tractors
- existing equipment must have Tier 4 or earlier ICE engine
- must operate at a seaport
- infrastructure is eligible for funding



Awards up to full incremental cost*

(*vehicle only)



- provide service to aircraft between flights
- provide support services around aircraft
- existing equipment must be diesel Tier 2 or earlier or spark ignition engine certified to 3 g/bhp-hr or higher emissions
- must be used at an airport



Awards up to \$2.5 million per vessel



- ferries, tugboats and towboats
- existing equipment must have Tier 2 or earlier ICE engine(s)
- can retain Tier 3 and Tier 4 engine(s)
- vessel replacement not eligible
- infrastructure is eligible for funding



Awards up to \$2.5 million per installation



- must not be required by regulation
- example of eligible costs: cabling, cable management systems, coupler systems, distribution controls
- must meet international design standards

Funding Examples

documentation

- ✓ proof of ownership
- ✓ usage records
- ✓ insurance documentation
- ✓ equipment price quote(s) (note: ZE + ICE for GSE)
- ✓ information about baseline and new equipment
- ✓ compliance documentation

- \$34 million in 1st installment funding
- \$10 million limit per awardee (combined for all project components)
